

Call for Papers: EAIS 7th Annual Conference on Israel Studies 2018
2nd - 4th September 2018

‘Israel's Turning Points: Histories and Narratives, Ruptures and Continuities’

The EAIS 7th Annual Conference on Israel Studies will take place from Sunday, 2 September to Tuesday, 4 September 2018 at SOAS, University of London, UK. The conference will be held in English.

The aim of the conference is to bring together international scholars from a variety of disciplines, who are engaged in research in any aspect of Israel Studies – including, but not limited to, Politics, Literature, Security, Minorities, Social Studies, History, Migration Studies, Gender Studies, Economics, Law, Religion, Anthropology, Language, Culture, Film, Music and Art. The Conference will centre on Israel's year of anniversaries, such as the First Zionist council (1897), the Balfour Declaration (1917), the Peel Commission (1937), the State of Israel (1948), the six-day war (1967), the Camp David Accords (1978), Oslo Accords (1993). By focusing on the idea of historical turning points, the conference aims not only to interrogate these crucial dates and anniversaries but also to reflect and critique the preconceived notions and ways in which we choose to frame history and represent the development of society and culture.

The conference organisers welcome all proposals from EAIS members that are pertinent to Israel Studies and the theme of the conference. Proposals for Panels or Round Tables (3 or 4 speakers) are especially welcome.
